## **Auditor General's report**

#### Audit opinion - Qualified

Except for those matters set out in my Basis for Qualification below, in my opinion no matters have come to my attention giving cause for concern that in any material respect, the information reported in this Annual Return:

- · has not been prepared in accordance with proper practices;
- · that relevant legislation and regulatory requirements have not been met;
- is not consistent with the Council's/Committee's governance arrangements; and
- that the Council/Committee does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

#### **Basis for Qualification**

In my opinion the Annual Governance Statement is inconsistent with the arrangements in place at the Council.

Assertions 1 and 4: The Council states it has made proper arrangements for the approval of the accounts and for the exercise of electors' rights to inspect the accounts. The Accounts and Audit (Wales) Regulations 2014 (the Regulations), require the Council to approve the accounts prior to the commencement of the electors' inspection period and to give 14 days' notice of the inspection period. The Council advertised its inspection period as being from 20 August 2021 to 17 September 2021. The notice was only displayed from 4 September 2021. The Council did not approve the accounts until 14 September 2021. Therefore, in my opinion, the Council failed to comply with the requirements of the Regulations and did not make proper arrangements for the approval of accounts or for the exercise of electors' rights of inspection.

### Other matters arising and recommendations

### **Accounting statement**

The balance brought forward (Line 1) reported for the 2019-20 comparative accounts of £11,770 is understated by £650. This leads to arithmetic errors in the 2019-20 and 2020-21 accounts. The correct entries are:
